



INTENSIVE ENGLISH PROGRAM – FINANCIAL INFORMATION FORM – 2021/2022

All students studying on F-1 on J-1 visas must submit a completed Financial Information Form and supporting bank statement before an I-20 or DS-2019 can be issued. A signed sponsorship letter may also be provided instead of the Financial Information Form. This form or letter provides evidence of the applicant’s ability to pay all required educational, insurance and living costs per session. This is not required for U.S. citizens, asylees or asylee applicants, permanent residents, dependent visas, or deferred-action (DACA) documentation.

The estimated average cost for one 8-week session of study in the Intensive English Program at UL Lafayette is:

All fees are subject to change without notice. These fees are based on on-campus living including the Cajun Classic meal plan. Off campus accommodations may be more expensive. Health insurance is mandatory for F-1 & J-1 students. For dependents to be included on the SEVIS I-20AB, add \$2,000 (spouse) or \$1,000 (per child) to the total of \$5,110.

A current bank statement of at least \$5,110 of liquid funding must be attached indicating that these funds are available for student use. While students are required to show proof of \$5,110, actual costs may be higher. The statement must be no older than 6 months and must indicate the exact numerical amount of funding. Pay stubs, investment funding, and bank statements of companies will not be accepted. Statements may be listed in any valid currency.
